
## Testing Results for Lead in Drinking Water for Norfolk Naval Shipyard, Scott Center Annex – Child Development Center – Building 1510

The Navy is committed to maintaining safe drinking water on its installations. City water supplied to the Navy and the Navy's water distribution system is regularly tested and in compliance with the Safe Drinking Water Act. Because lead exposure is a particular concern for children, and lead may be introduced to drinking water through the pipes, fittings, solder, and fixtures inside a building, the EPA recommends, but does not mandate, that we test the lead content of drinking water in priority areas such as youth centers (YC), child development centers (CDC), and child development group homes (CDGH).

Navy environmental personnel conducted lead testing at the Norfolk Naval Shipyard, Scott Center Annex – CDC – Building 1510 in accordance with Navy and EPA guidelines. Samples from various locations in the CDC were sent to a state-certified laboratory for analysis.

At the Norfolk Naval Shipyard, Scott Center Annex – CDC – Building 1510, outlets used for drinking and cooking, as well as outlets used for hand washing were tested. All 16 of the outlets tested were within EPA's recommended lead level of 20 ppb. One part per billion is equal to one drop of water in an Olympic-size swimming pool.



A copy of all test results is enclosed for your information. The test results are presented in two tables:

- Table 1 <u>Summary of Results</u> summarizes the data by category of use (e.g., drinking, cooking, washing).
- Table 2 **Summary Statistics** summarizes all the data.

**Table 1** provides a description of each sampling location using three columns; *Category*, *Outlet No.*, and *Outlet Description*. The *Category* column gives information about whether the outlet is used for drinking water (water fountain), cooking (food preparation), or washing (primarily hand-washing). The *Outlet No.* column is the number used to identify each outlet location and

corresponds to the outlet number on the floor plan. The *Outlet Description* column contains additional information to describe the outlet sampled under each category.

The next set of columns in **Table 1** provide *Initial Sampling Results*, and for those locations that exceeded the recommended level of 20 ppb, the *Re-sampling Results*.

EPA sampling protocol requires water to not be used for between 8 and 18 hours prior to first draw sampling. Therefore, the *Initial Sampling Results* include a sub-column for *First Draw* samples collected early in the morning before the CDC opened and before any water was used. Additional sub-columns indicate whether *Retesting* is required and the *Date Secured* for fixtures greater than 20 ppb.

The *Re-sampling Results* columns are annotated N/A since all samples at the Norfolk Naval Shipyard, Scott Center Annex – CDC – Building 1510 were within EPA recommended levels.

The *Corrective Actions* column describes actions that have been taken to remediate the source of lead. In the event that future fixtures or upstream piping is replaced, there are columns for *Post Remediation Sampling* data that will be documented to confirm that these corrective actions were successful in reducing lead below 20 ppb.


