Frequently Asked Questions:

Q1. Is the accused currently in pre-trial confinement in a military brig?

A1. Yes. The accused is being held at Navy Consolidated Brig Chesapeake.

Q2. Why is the accused being held in pre-trial confinement?

A2. There is a concern that the accused may be a flight risk and may commit additional serious misconduct if the member is not in pre-trial confinement.

Q3. Is the accused receiving a salary during legal proceedings?

A3. Yes, the accused is currently in an active duty status.

Q4. When will the General Court-Martial be heard?

A4. TBD.

Q5. May I speak with the accused?

A5. No. Requests for interviews are currently denied.

Q6. May I speak with the trial counsel?

A6. Requests for comments from military counsel are currently denied, however, you may contact the civilian counsel for the accused.

Q7. If convicted, what's the maximum possible sentence?

A7. The maximum possible punishment is 64 years confinement, Dishonorable Discharge, Reduction to E-1, and total fines and forfeitures.
