**Subj: IDENTIFICATION OF OFF-LIMITS ESTABLISHMENTS**

**Ref: (a) OPNAVINST 1620.2A  
(b) Joint MOU of 23 Aug 13**

- 1. Purpose. To identify establishments operating in Southeastern Virginia and Northeastern North Carolina areas that are declared off limits to Armed Forces personnel.**
- 2. Information. As a result of recommendations by the Armed Forces Disciplinary Control Board for Southeastern Virginia and Northeastern North Carolina, and acting in accordance with references (a) and (b), the below-listed establishments are off limits to members of the Armed Forces:**
  - a. The Vault, Vape and Hookah Shop, FKA The Vault, 15435-B Warwick Blvd, Newport News, Virginia 23608.**
  - b. The Vault, Vape and Hookah Shop, FKA Unwind, 731 J. Clyde Morris Blvd, Ste. B, Newport News, Virginia 23601.**

  - d. Mellow Smoke Tobacco Shop, 201 East Berkeley Avenue, Ste. C, Norfolk, Virginia 23523.**
  - e. Outer Edge Gifts, 760-B J. Clyde Morris Blvd, Newport News, Virginia 23601.**
  - f. 7 City's Custom & Design AKA Envy Car Audio & Design and Unique Auto Design, 1062 37th Street, Norfolk, Virginia 23508 or 117 Princess Anne Road, Norfolk, Virginia 23510, Autoworks, 6100 Tidewater Drive, Norfolk, Virginia 23509, and D Motors, 881 East Little Creek Road, Norfolk, Virginia 23518.**


