NAVSUPPACT NORTHWEST ANNEX INSTRUCTION 5355.1C

Subj: NAVAL SUPPORT ACTIVITY NORTHWEST ANNEX COMMAND URINALYSIS

SCREENING PROGRAM AND PROCEDURES

- 1. Purpose. To provide policy and procedures per reference (a) for the Urinalysis Screening Program (USP) administered by Naval Support Activity (NAVSUPPACT) Northwest Annex, for all assigned military personnel, as well as any tenant activity requesting NAVSUPPACT Northwest Annex USP support (as agreed to in a signed Memorandum of Understanding (MOU)). This instruction applies to all NAVSUPPACT Northwest Annex personnel and only those tenants with a current MOU.
- 2. Cancellation. NAVSUPPACTNWINST 5355.1B
- 3. <u>Background</u>. An individual who is under the influence of a mind-altering or central nervous system-influencing drug jeopardizes combat readiness, safety, discipline, judgment, and loyalty. A USP is a system of biomedical testing of urine samples that not only identifies drug abusers, but also serves as a strong deterrent against drug abuse, and provides statistical data on the prevalence and demographics of drug abuse.
- 4. <u>Discussion</u>. References (a) through (e) provide specific guidance for, and authorize the use of, a USP as a tool to deter drug abuse and aid in the enforcement of the Navy's "Zero Tolerance" drug use policy.
- 5. <u>Policy</u>. Drug abuse can seriously damage physical and mental health, jeopardize personal safety and the safety of others, and lead to criminal prosecution and a discharge under less than honorable conditions.

Drug abuse detracts from operational readiness, and is inconsistent with Navy Core Values and initiatives to promote personal excellence and a healthy lifestyle among Navy personnel. Per references (a) and (b), the goals of NAVSUPPACT Northwest Annex are a drug-free workplace and the deterrence of future drug use via a rigorous USP. A "Zero Tolerance" drug abuse policy is the standard of the Navy and of this command.

6. Responsibilities

a. Officer in Charge. Responsible for understanding and aggressively implementing policy and taking immediate corrective action upon personnel involved in drug abuse and violations of the Uniform Code of Military Justice (UCMJ).

Officer in Charge (OIC) shall.

- (1) Conduct an aggressive USP per Ref (a).
- (2) Schedule random urinalysis sampling of small numbers of personnel on a frequent basis. This will reduce the predictability of command testing and raise the perceived risk of detection. All types of testing, including tests performed as a result of directed searches, inspections, fitness for duty evaluations, etc., will be applied toward the unit's quota. The minimum monthly testing requirement is four times a month. The four tests must include a minimum of 15 percent of all assigned personnel, with a maximum of up to 40 percent of assigned personnel tested. Ensure an end of fiscal year unit sweep for all members not tested throughout the course of the year.
- (3) Appoint a Urinalysis Program Coordinator (UPC) in writing (recommend E-7 or above). Drug and Alcohol Program Advisors (DAPAs) and Independent Duty Corpsmen (IDCs) shall not be assigned duties as a UPC.
- (4) Ensure all personnel assigned duties as the UPC or observers receive proper training per reference (a).
- (5) Protect the confidentiality of records containing information on the identity, diagnosis, prognosis, or treatment of individuals in a drug abuse program as required by federal law.

- (6) Submit Drug and Alcohol Abuse Reports (DAARs) (OPNAV 5350/7) to Alcohol and Drug Management Information Tracking System (ADMITS) per reference (a).
- (7) Ensure all newly reporting personnel are thoroughly briefed on command policy and punitive consequences for failure to obey official Navy policy pertaining to illicit drug use/abuse, and are administered a urinalysis within 72 hours of arrival using the unit sweep (IU) premise.
- (8) Immediately process for administrative separation all military personnel who are determined to be drug abusers per Naval Military Personnel Manual (NAVPERS 15560D).

b. UPC shall.

- (1) Administer the command USP per reference (a).
- (2) Meticulously maintain all urinalysis files (36 months plus current).
- (3) Ensure observers and assistant UPCs are properly trained, to include the UPC NKO course for observers and assistants.
- (4) Maintain and update directives and instructions pertaining to urinalysis.
 - (5) Ensure command compliance with Navy directives.
- (6) Strictly follow chain of custody procedures as outlined in reference (c).
- (7) Collect other authorized urine samples in accordance with the premise codes outlined in reference (a).
 - (8) Ensure NDSP version 5.2 or greater is used.

c. The Urinalysis Screening Observer shall.

- (1) Observe the taking of the samples per reference (a).
- (2) Review and sign enclosure (1).

- (3) Be an E-5 or above and the same gender as the personnel being observed.
- (4) Attend **ALL** training provided by the UPC and comply with guidelines outlined in enclosure (1).
- 7. Hours of Operation. Routine hours of operation for urinalysis collection are from 0730-1500, on the day of selection, as determined by the Navy Drug Screening Program, or as modified by the OIC. This permits shift workers to participate in collection.

8. Collection Procedures

- a. On testing day, the Navy Drug Screening Program will randomly select personnel to be tested that day. The UPC will notify selectee's in writing via their chain of command. Email is the preferred means of written notification. The selectee's chain of command will direct the selectee to report to the UPC as per notification guidelines. They will relinquish their military identification card to the UPC.
- b. The individual being tested will remain under observation by the Urinalysis Screening Observer until they provide a urine sample. Should a member be unable to provide a sample during the command's prescribed collection period, the member shall be examined by a military medical authority to investigate the possibility of physiological or psychological problems per reference (a).
- c. Once specimens have been provided, the UPC will collect, document, package, and transport all samples collected per the guidelines established in references (a) through (c), ensuring an irrefutable chain of custody is maintained.
- 9. Failure to Report for Testing. OIC will place SNM on report for violation of UCMJ Article 92, any designated individual failing to report and/or provide a urine sample.
